CODE OF CONDUCT FOR MEMBERS

1. The Narre Warren Bowls Club Inc. advises its members & Guests that under the Club's Code of Conduct, the Club expects all members and non-members, whilst on Club premises to -
 - (a) Respect and comply with the Rules & By-Laws as laid down in the Club Constitution and the Etiquette of Bowls and the decisions of all committees elected by the members;
 - (b) At all times act in the best interests of the club and not tolerate or participate in any improper or unsatisfactory behaviour;
 - (c) Not act in an abusive, threatening, or intimidating manner;
 - (d) Not use obscene, offensive, abusive, threatening, or intimidating language;
 - (e) Not act in an unsportsmanlike manner;
 - (f) Not threaten any person with physical violence or assault;
 - (g) Not assault any person;
 - (h) Not act in a manner likely to bring the sport of bowls into disrepute; or
 - (i) Act in a manner likely to bring Bowls Victoria into disrepute.
 - (j) Not remove or damage any property owned by or under the control of the Club;

2. Any member or non-member who has a grievance against another member of the Club shall deliver such grievance in writing to the Secretary within fourteen (14) days in accordance with the Club Constitution;

3. Any member or non-member who contravenes these Rules or By-Laws shall be dealt with by the Board in accordance with the Club Constitution.

4. In accepting membership to the Narre Warren Bowls Club, I agree to comply with the Code of Conduct.
